ADDITIONAL TERMS AND PROVISIONS

(A) Definitions, Capitalized terms used herein shall have the following meaning:

1. "Church" shall mean Willowbrook Christian Church, 619 High Street, Victor, New York 14564.
2. "Church's Property" shall mean the real property and improvements located at 619 High Street, Victor, New York 14564.
3. "Occupant" shall mean the person or entity appearing in Box 1 of this agreement, and shall also include the Occupant's invitees and licensees.
4. "Occupied Space" shall mean the room or space described in Box 2 of this agreement.

(B) Indemnification, The Occupant will protect, indemnify and save harmless the church from and against all liabilities, obligations, claims, damages, penalties, causes of action, costs and expenses (including, without limitation, reasonable attorneys fees and expenses) imposed upon, incurred by or asserted against the Church by reason of (a) any accidents, injury to or death of any person or loss of or damage to property occurring on or about the Church's Property or (b) any other loss or damage arising from the Occupants use of the church's Property.

(C) Facilities Handbook, The Occupant has received the Church's Facilities Handbook. The Occupant shall cause all persons using the Occupied Space to review and comply with the Facilities Handbook. The Occupant agrees and acknowledges that upon violation of the rules and regulations in the Facilities Handbook, the Church may immediately terminate this Agreement and require the Occupant or any other person occupying the Occupied Space to immediately vacate the Church's Property.

(D) Damage to Church Property, The Occupant shall be responsible for reimbursing the Church for any damages to the Church's Property caused by the Occupant. Any such costs or expenses for damage shall be paid to the Church by the Occupant on demand.
